When: Spring term 2018 (March 20 - May 30).

Expectations:

- Resident Artists will design and teach a course in their area of expertise meeting 2.5 hours two days a week, and should be available to students an additional 3-5 hours weekly.
- Artist/Residents are expected to spend a minimum of 5 days per week on site.
- Artists will produce a body of work to be exhibited during the final week of their residency. Applicants should hold an MFA or a record of equivalent professional achievement.
- Artists will engage the Galesburg community in collaborative or community-based projects or events.
- Artists will donate a work to Knox College.
